

A BYLAW OF THE TOWN OF OUTLOOK
TO PROVIDE FOR THE CLOSING OF A
CERTAIN LANE AND STREETS IN THE
TOWN OF OUTLOOK

WHEREAS it is necessary and desirable to close a certain lane and streets in the Town of Outlook, in the Province of Saskatchewan.

NOW THEREFORE, the Council of the Town of Outlook enacts as follows: -

- THAT (1) the lane in Block C; and
- (2) the portions of Cross Street lying to the south of a straight line joining the North-West corner of Lot 3, in Block C, with the North-East corner of Lot 4, in Block D; and
- (3) the portion of Maple Street lying to the south of the production westerly of the North limit of Lot 3 in Block D,

as said lane, streets, lots, and blocks are shown upon a plan of survey of record in the Land Titles Office for the Saskatoon Land Registration District as Number G411

BYLAW NO. 1(77)

A BYLAW OF THE TOWN OF OUTLOOK
TO PROVIDE FOR THE CLOSING AND CONSOLIDATING
OF CERTAIN LANES, STREETS AND AVENUE
IN THE TOWN OF OUTLOOK.

WHEREAS it is necessary and desirable to close certain lanes,
streets and avenue in the Town of Outlook, in the Province of Saskatchewan.

NOW THEREFORE, the Council of the Town of Outlook enacts as
follows: -

- (1) THAT: (a) the portion of East-West lane in Block G; and
(b) the portion of River Avenue lying to the West of a
straight line joining the North-East corner of Lot 22,
in Block G, with the South-East corner of Lot 24, in
Block R; and
(c) the portions of Cross Street, Maple Street and Prospect
Street; and
(d) the lanes in Blocks H, K, O, and P

as said Lots, Blocks, Lanes, Streets and Avenue are shown upon a plan
of survey of record in the Land Titles Office for the Saskatoon Land
Registration District as Number G378

BE CLOSED

- (2) THAT: the above described closed areas be consolidated with

Lots 1 to 9 inclusive in Block G,
Lots 22 to 33 inclusive in Block G,
Lots 1 to 33 inclusive in Block H,
Lots 1 to 36 inclusive in Block K,
Lots 1 to 24 inclusive in Block O,
Lots 1 to 24 inclusive in Block P,
Lots 13 to 24 inclusive in Block R,
and
