## BYLAW NO 11 (68)

A BYLAW of the TOWN OF OUTLOOK to provide for the protection, care, management, and control, of park areas to ensure their use and enjoyment as public parks and pleasure grounds; and for the conduct of persons residing in or making use of park areas.

A. The Council of the Town of Outlook enacts as follows:

1. In this Bylaw the expression "park area" means any area set aside by the Town of Outlook as a public park or playground area and shall include:

Lots one (1), Two (2), Three (3), Four (4), Five (5), Six (6), Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11), Twelve (12), Thirteen (13), and Fourteen (14), in Block One: Lots One (1), Two (2), Three (3), and Four (4), in Block Two (2): Lots One (1), Two (2), Three (3), and Four (4) in Block Three (3), Townsite of Outlook, in the Province of Saskatchewan, in the Dominion of Canada, according to a Plan of Record in the Land Titles Office for the Saskatoon Land Registration District as Number G707.

All of Block L in the Townsite of Outlook, in the Province of Saskatchewan in the Dominion of Canada, according to a Plan of Record in the Land Titles Office for the Saskatoon Land Registration District as Plan G39.

All of Block M in the Townsite of Outlook, in the Province of Saskatchewan in the Dominion of Canada, according to a Plan of Record in the Land Titles Office for the Saskatoon Land Registration District as No. G39.

All of Block N in the Townsite of Outlook, in the Province of Saskatchewan, in the Dominion of Canada, according to a Plan of Record in the Land Titles Office for the Saskatoon Land Registration District as No. G378.

Lots One (1), Two (2), Three (3), Four (4), Five (5), Six (6), and Seven (7) in Block Fifty-six (56) in the Townsite of Outlook, in the Province of Saskatchewan, inthe Dominion of Canada, according to a Plan of Record in the Land Titles Office for the Saskatoon Land Registration District as Plan G358.

"Officer" means any person employed in connection with the administration and management of a park area.

"Domestic Animal" includes any head of cattle, horses, mules, asses, sheep, goats, swine, dogs, or cats;

"Vehicle" means any automobile, truck, trailer, trailer unit, or other conveyance.

Entry Permit 2. The Park Board may require from time to time that entrance to any park be subject to reasonable conditions including payment of a prescribed fee and thereafter no person shall enter such park except on payment of such fee.

Specific Purpose No person shall use any park area set aside for a specific purpose for any other purpose prejudicial to such use except with the permission of an officer.

Fire

4. No person shall light any outdoor fire in a park area except in a fireplace provided for that purpose without permission of an officer.

- 5. No bonfire or other exposed fire shall be kindled to dispose of rubbish in any park without a permit to do so which shall state the place and time of such burning and all such burning shall be done between sunrise and 8 p.m. when a competent person shall be constantly in charge of the fire until it is extinguished.
- 6. No person by himself, or by his servant, agent or employee shall throw, place, deposit or leave: (a) any dirt, stones, filth, glass, rubber, plastic, metal or similar matter of any kind; or

(b) any garbage, refuse, rubbish or wastes of any kind; or

(c) any offensive or dangerous matter; in any park area except in a place designated for such purpose.

6a. Any person by himself or by his servant, agent or employee, throwing, placing, depositing or leaving anything referred to in section 6 in a park area shall wintin twenty-four (24) hours after having been notified by an officer, remove the same as directed by the notice, and in the event of failure to do so the officer may secure the removal of same.

## Temporary Residence

- 7. No person shall establish any temporary residence, trailer unit or tent in a park area without a permit which may be issued by an officer.
- 8. Any person using any cabin, trailer, tenting or other area shall keep such area in a clean and satisfactory state.

## Wastes

- 9. No person shall leave or dispose of any broken glass, bottles, cans or similar refuse on or in any place in a park area except on or in a place and in a manner designated by an officer.
- Nuisances 10. No area of any park may be used in such a way as to and pollute, contaminate or cause other injury to the water or swimming pool within a park.
- Defacing II. No person shall tamper with, deface, cut into, write upon or otherwise disfigure or destroy any natural rock formation, soil, tree, timber, bridge, building, seat or any other structure in a park.
- Defacing 12. No person shall remove, deface or destroy any notice Signs posted in a park in regard on any matter relating to the administration of any park.
- Dogs
  13. No person shall allow or bring any dog upon any bathing area or playground or within any public building within a park.
- Domestic 14. Where any person allows any domestic animal to be Animals in any park area in contravention of this Bylaw, the owner shall be deemed to have violated the said Bylaw.
- Firearms 15. No person shall have in his possession any firearm, airgun, air pistol, bow and arrow or other dangerous weapon or devise unless authorized by an officer.
- Firecrackers 6. No person shall have or use within any park area any fireworks, firecrackers or other explosive or highly flammable matter except under the authority of a permit which may be issued by an officer.

- 17. Except with the permission of an officer, no person shall:
  - (1) hunt, shoot, trap, snare, poison or otherwise destroy or molest an animal or bird; or
  - (2) carry or have in his possession or discharge any firearm or airgun or any bow and arrow; in. within or across any park area

Traffic

- in, within or across any park area.

  18. No person shall have, drive or park any vehicle in any park area except on roadways or parking areas designed for the use of vehicles.
- 18a No person shall use any motorcycle, bicycle or other motor driven or footpropelled vehicle on foot paths in playground areas within a park area.
- 19. The speed limit for all vehicles within a park area shall be Fifteen (15) miles per hour.
- 20. During the hours when the swimming pool area is closed to the public, no person shall enter the swimming pool area for the purpose of swimming or for any other reason unless authorized by permit by an officer.
- 21. Any person who fails to comply with posted regulations with respect to a swimming pool or playground area is guilty of an offence and liable to penalties as provided, upon conviction.
- 22. No person suffering from a communicable or contagious disease shall enter a swimming pool in a park area.
- 23. The officer in charge, lifeguard or public health nurse is hereby authorized and empowered to demand from any person, before entering the Pool, a certificate from a Physician that such person is not suffering from any communicable or contagious disease, and to restrain such person from entering the Pool until such certificate is produced.
- 24. A person convicted of a violation under the provisions of this Bylaw shall be subject to penalties as provided under the General Penalty Bylaw of the Town of Outlook; in addition the convicting magistrate or Justice of the Peace shall order that a sum equivalent to the value of the thing destroyed, or a sum equivalent to the cost of repairing the thing damaged, as the case may be, be paid to him forthwith or within a stated period, the said sum or sums to be subsequently handed over to the Town of Outlook.

This Bylaw shall come into force and take effect from the date of final passing thereof.
