

BYLAW NO. 11(71)

A BYLAW OF THE TOWN OF OUTLOOK AUTHORIZING  
COUNCIL OF THE SAID TOWN TO ENTER INTO A  
HOUSING AGREEMENT.

WHEREAS provision is made in the Housing and Urban  
Renewal Act, 1966 Chapter 53, R.S.S. 1966, enabling the Council of  
any Municipality, subject to the approval of the Local Government  
Board, to enter into a Housing agreement or Agreements as contemplated  
by Section 4 of the said Act, and

WHEREAS the Council of the Town of Outlook deems it  
expedient to undertake a Housing Project within the terms of the said  
Act;

NOW, THEREFORE, the Council of the Town of Outlook  
enacts as follows:

(1) That the proposed agreement hereunto annexed  
and marked as Schedule "A" to this Bylaw and which  
is deemed to be part of this Bylaw, being tripartite  
Agreement between:

represented by the Honourable Everett I. Wood,

Minister of Municipal Affairs,

(hereinafter called "the Provincial Minister")

CENTRAL MORTGAGE AND HOUSING CORPORATION

(hereinafter called "the Corporation")

(JOINTLY hereinafter called "the Partnership")

OF THE SECOND PART:

AND:

THE TOWN OF OUTLOOK

(hereinafter called "the Town")

OF THE THIRD PART:

be and the same is hereby ratified and confirmed.

(2) That the Mayor and the Town Administrator for the Town of Outlook be and they are hereby authorized and empowered to sign the said Agreements on behalf of the Town.

(3) That this Bylaw shall come into Force and take effect from the date of final passing thereof, subject to prior approval of The Local Government Board.
