BYLAW NO. 13(2000)

A BYLAW OF THE TOWN OF OUTLOOK TO PROVIDE FOR ENTERING INTO AN AGREEMENT UNDER SECTION 175(1)(b) OF THE URBAN MUNICIPALITY ACT, 1984, RESPECTING A RENTAL AGREEMENT.

The Council of the Town of Outlook in the Province of Saskatchewan, enacts as follows:

1. The Town of Outlook is hereby authorized to enter into agreement, attached hereto and forming part of this bylaw, and identified as "Exhibit A" with the following:

OUTLOOK SCHOOL DIVISION #32, of Outlook in the Province of Saskatchewan,


for the purpose stated within the agreement.

This agreement can be changed at anytime by mutual consent of both parties.

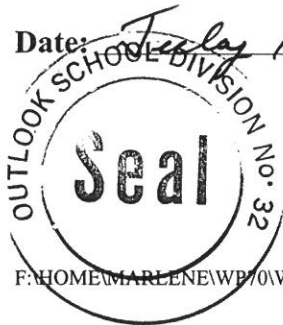

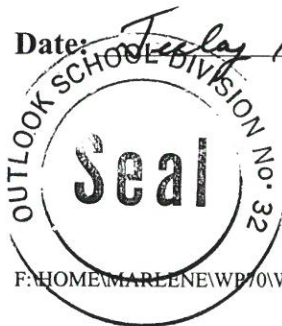
