BYLAW NO. 17(1999)

A BYLAW TO DEDICATE LAND AS MUNICIPAL RESERVE PURSUANT TO SECTIONS 194.1 AND 205.1 OF THE PLANNING AND DEVELOPMENT ACT, 1983.

The Council of the Town of Outlook in the Province of Saskatchewan, hereby enacts to dedicate as municipal reserve the following land in and owned by the Town of Outlook:


- 1) All that Portion of the North West Quarter of Section 16
Township 29
Range 8
West of the Third Meridian, Saskatchewan
lying to the West of the left bank of the South Saskatchewan River
36 acres on Township Survey dated 16 May 1885
Except: 2.668 acres for Roadway on Plan D4390

- 2) That this bylaw become effective on the date it is registered in the Saskatoon Land Titles office.

INTRODUCED AND READ a first time this 21st. day of December, 1999.



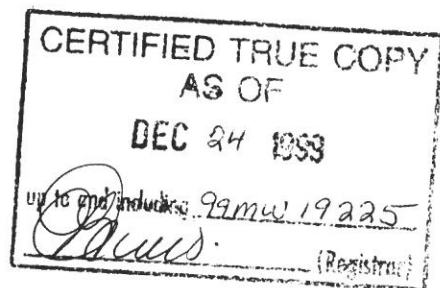
