# TOWN OF OUTLOOK BYLAW NO. 05 (2024)

### A BYLAW FOR PUBLIC DISCLOSURE STATEMENTS

The Council of the Town of Outlook in the Province of Saskatchewan enacts as follows:

- 1. This Bylaw may be cited as the "Public Disclosure Statement" Bylaw.
- 2. This bylaw has been created to comply with section 142 of *The Municipalities Act* and as outlined in section 3.2 of *The Municipalities Regulations*.
- 3. In this bylaw:
  - a) "Administrator" shall mean the administrator of the municipality;
  - b) "Council" shall mean the Council of the Town of Outlook.
- 4. Every member of council shall file within 30 days of being elected a public disclosure statement with the Administrator on Public Disclosure Statement Form 1 as annexed hereto.
- 5. Every member of council who has previously filed a public disclosure statement pursuant to Section 4 shall annually submit a declaration on or before November 30<sup>th</sup> in each year to the Administrator on Public Disclosure Annual Declaration Form 2 as annexed hereto.
- 6. Every member of council submits to the Administrator any material change(s) to his/her initial disclosure on Public Disclosure Statement Amendment Form 3 as annexed hereto.
- 7. A council member may revise his/her disclosure statement any time a material change occurs or if he/she or another person notices an error or omission.
- 8. Bylaw 04 (2018) is hereby repealed.

9. This bylaw shall come into effect on the day of its final passing.
