BYLAW NO 14 (2019)

A BYLAW TO APPOINT A BYLAW ENFORCEMENT OFFICER

The Council of the Town of Outlook, in the Province of Saskatchewan enacts as follows:

- 1. For the purpose of this bylaw, the expression:
 - a) "Council" means the Council of the Town of Outlook; and
 - b) "Municipality" means the Town of Outlook.
- 2. Council hereby appoints Commissionaires North Saskatchewan as the Bylaw Enforcement Officer(s) for the Municipality.
- 3. The appointment shall commence on November 1, 2019, and shall continue at the pleasure of council.
- 4. The appointment may be terminated by Council or by the Bylaw Enforcement Officer giving thirty (30) days' written notice.
- `5. The duties of a Bylaw Enforcement Officer shall be
 - a) to enforce all municipal bylaws enacted by the council of the Municipality
 - b) to represent the Municipality before a justice of the peace or provincial court judge in the prosecution of anyone who is charged with contravention of a bylaw; and
 - c) other duties as may be assigned by council or its delegate.
- 6. Bylaw No. 12(2012) and Bylaw No. 06(2014) are hereby repealed.
- 7. This bylaw shall come into force and take effect on the date of final passing thereof.

BY-LAW ENFORCEMENT CONTRACT

This is to confirm that the Town of Outlook has agreed to contract the services of Commissionaires North Saskatchewan as Bylaw Enforcement Officers.

- Service to be provided as follows:
 - 1 day per week for a total of 8 hours subject to change upon demand
- Days will vary throughout the week.
- Visits include traveling time from Saskatoon, Sk.
- Visits can be requested on specific events or need through mutual consent.

Contract Expiry/Renewal Date: September 30th, 2020.

 The Town of Outlook can exercise option to increase hours / visits if required, and may also request additional Bylaw Enforcement services for specific events during the contract year.
