Please submit with this application a copy of a site plan or survey*. These diagrams will show the site property boundaries (property lines), all structures on the property, all structures on adjacent lots, all rights-of-way and easement locations, and the proposed location of the fence on the property.

It is the responsibility of the Applicant to verify all locations of property lines, rights-of-way, and easements when applying for a fence permit. NOTE: The location of a property line is most often NOT along a sidewalk or curb.

**Corner Lots: When building or replacing a fence on a corner lot, extra care must be taken to avoid placing any part of the fence in the public right-of-way. If the application is for a fence to be built or replaced near the property line adjacent to a street, a survey may be required to verify the location of the public right-of-way before permit approval.*

4.7 FENCES

- 4.7.1 A principal building or use must be established on a site prior to the erection of a fence or wall on the site.
- 4.7.2 A fence may be erected to safeguard public safety on a site during the period of construction of the principal building or use or due to the presence of a natural hazard on the site.
- 4.7.3 No wall, fence or other structure not otherwise permitted shall be erected in a required front yard or on a site line adjacent to a required front yard to a height of more than 1.0 metres above grade level.
- 4.7.4 No wall, fence, screen or similar structure, excepting permitted accessory buildings, shall be erected in a required side or rear yard, or on a site line adjacent to a required side or rear yard, to a height of more than 2.0 metres above grade level.
- 4.7.5 Sections 4.7.1 and 4.7.2 (above) do not apply in C1, C2, M or FUD districts, except that in the case of a corner site, no wall, fence, screen, hedge or other structure shall be placed so as to create a visual obstruction in an established intersection sight triangle.
- 4.7.6 A development permit is required for the erection of all fences.
- 4.7.7 Fences constructed of barbed wire, chicken wire, or similar materials shall be prohibited.

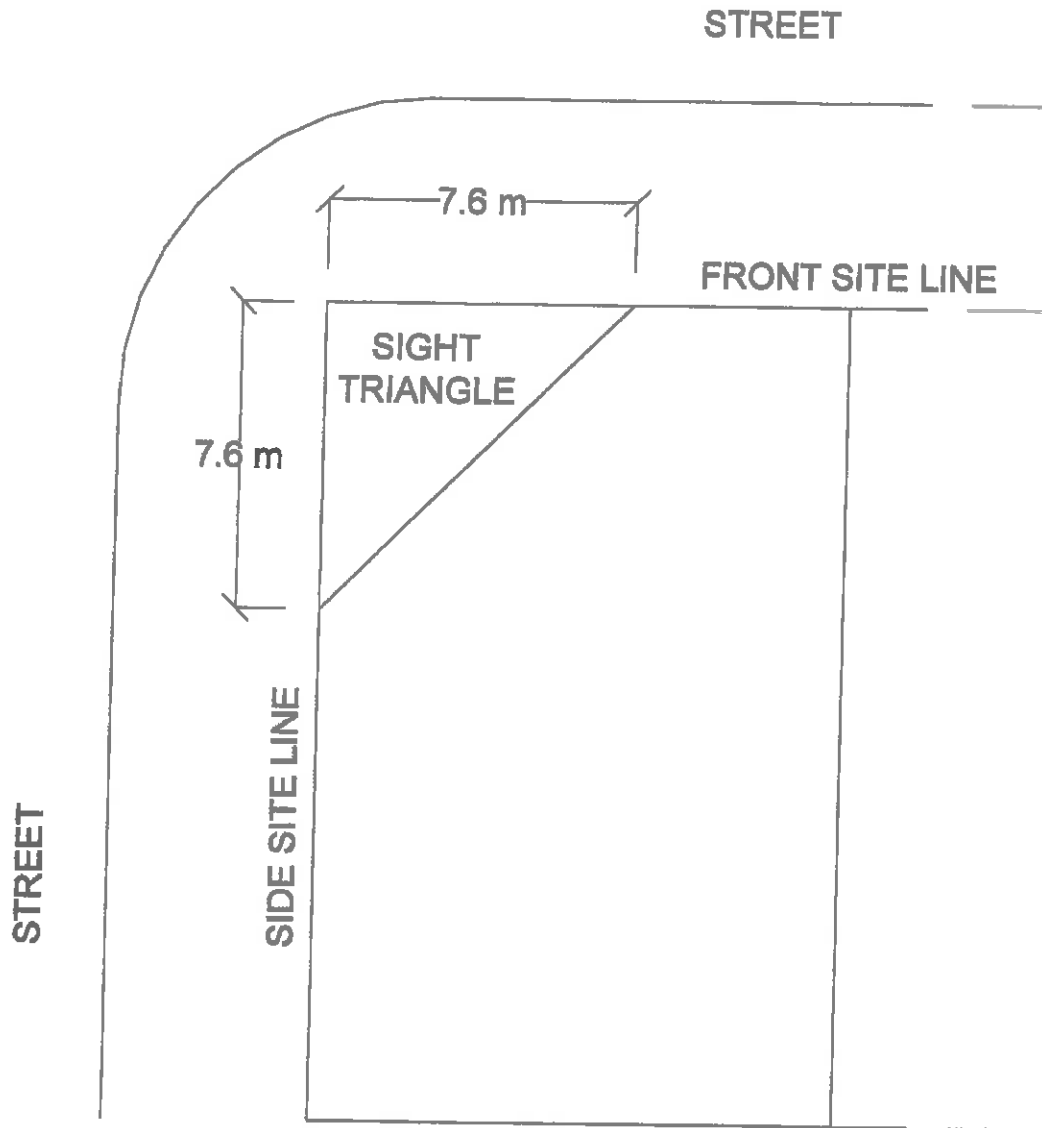


FIGURE 2-3: Sight Triangle
