For this reason, Council sincerely apologizes to Mr. Steve Pawlus; and, finally, in its continuing efforts to hold each other accountable, to act as an ear for the public to air their concerns in a meaningful manner, to be transparent and accountable, Council reaffirms its commitment to abide by The Municipalities Act, the Town of Outlook Council Code of Ethics and the Council Procedures Bylaw of the Town of Outlook ensuring that the integration of these acts, codes and bylaws, among others, will safeguard that conduct such as this will not occur without censure and consequence in the future.
