

# Policy Title: <u>SNOW MANAGEMENT</u>

Policy Objective/Priority	First, to provide critical services and access to emergency facilities and Town services; next, to restore mobility along key routes; then, to restore mobility on lower traffic streets (residential) and finally to restore parking availability and improvement of sight lines at intersections after snow fall events or snow accumulations.

# LEGISLATIVE AUTHORITY

The Municipalities Act

### **OBJECTIVE**

Town Council enacts this policy to provide consistent and clear snow moving/removal practices for the Town of Outlook. In an effort to be transparent to the public, the snowfall response plan is to guide the team through a phased approach in a snowstorm to ensure public safety and restore mobility on Outlook streets and sidewalks.

### SCOPE

This policy applies to all Town of Outlook staff, contractors of the Town of Outlook or their assigns.

### **POLICY**

### 1. POSTING:

Posting notice of snow moving/removal will occur wherever practicable, providing as much advance warning as possible to accommodate the owners' removal of vehicles from the streets. Posting of priority categories and timeline will occur on the website and reminded regularly in season through various media.

### **DEFINITIONS**

"Snow Event" – snowfall or accumulation of at least ten centimeters but not such that requires a 4 wheel drive to be able to travel on town streets

"Snow Emergency" - reduced mobility to the point that light vehicles cannot travel on town streets, mobility across the town is severely impacted, and routine street maintenance does not meet the required level of service

"Local Snow Event" – reduced mobility to the point that light vehicles cannot travel on specific street(s) due to wind causing drifting, or other; this event can delay the timeline defined in this policy

#### 2. SNOW EVENT PHASE TIMELINE

a. In the case of a snow event, this timeline starts at 6 am of the regular workday following the end of the snowfall or accumulation:

Phase**	Timing from end of Snowfall or Accumulation*	Action		
1	First 12-24 Hours	Grading and plowing priority 1 a and b streets, access to emergency facilities, access to critical Town services, clearing major pedestrian pathways, removing driveway ridges as we go		
2	Within 36 Hours	Grading and plowing remaining priority 2 streets, removing driveway ridges as we go, removing snow from meridians/center lines on Saskatchewan Avenue from McKenzie St to 50 meters east or as needed to enable use of the corner		
3	Within 5 business days, but no more than 7 days	Grading remaining priority 3 streets, removing driveway ridges as we go, removing snow from meridians/center lines		
4	Within 6 business days, but no more than 10 days	Grading all remaining streets (priority 4 and commercial back alleys), clearing all pedestrian pathways		
5	Within 4 weeks	Removing stored snow for parking availability and improved sight lines, complete pedestrian walkways		
6	As equipment/personnel are available	Graded ridges along curb may be pushed back or hauled away to widen streets. Removing residential back-alley ridges. Method(s) chosen will be based on amount of snow; location of adjacent sidewalk (if any); proximity to intersection (blocking sight lines)

\*\* In the case of a non-snow event related emergency or a state of emergency, phases may change, the public will be informed of the necessary changes through the media

#### 3. SNOW EMERGENCY PHASE TIMELINE

a. In the case of a snow emergency, this timeline starts within 6 hours or at 7am of the day (whichever is reasonable) following the end of the snowfall or accumulation:

2	Within 48 Hours	Grading and plowing remaining priority 2 streets, removing driveway ridges as we go, removing snow from meridians/center lines on Saskatchewan Avenue from McKenzie St to 50 meters east or as needed to enable use of the corner
3-6	As Per Snow Event

### 4. PRIORITY MAP:

A priority map has been developed and is an appendix to this policy, referred to as MAP-PUB-001

#### 5. DE-ICING OF STREETS:

- 1. Sanding units will occur upon an occasion of freezing rain and lower than 0 degrees Celsius temperatures.
- 2. Sanding units will occur upon any 'shining' of street surfaces due to snowfall or changes in temperature.
- 3. Necessary stop signed street intersections will be sanded first, followed by yield street signed intersections, then uncontrolled intersections.
- 4. Full coverage sanding may occur in school zones, at the hospital, post office, and on the Town portion of the highway, as circumstances dictate.
