

The Town of Outlook, population 2381 (2021 census) is located on Highway 15, along the South Saskatchewan River, approximately 50 minutes south of the City of Saskatoon. We invite tenders for residential solid waste (garbage) transportation services delivered to the residents within the Town of Outlook (including acreages located on the west side of the river). The bid package involves:

1. Provision of approximately 1,000 (with ability to expand through the life of the contract), 95 litre carts in support of the automated curbside pickup system of the bidder
2. Biweekly curbside emptying of waste in the carts on regular dates and:
 - A. Delivery of waste to Outlook Regional Landfill
 - B. Delivery of waste to the bidders' own landfill(the Town is interested in receipt of pricing for both of the following options for comparison purposes, however only one will be selected)
3. The bidder should specify the per cart per month pricing on the bid form.
4. The bidder should specify the start date that they are prepared to begin the contract, however the start date SHOULD BE no later than May 1, 2026.
5. The term of the contract shall be 2 years with pricing locked in for the full term of the contract.
6. There is a parallel recycling tender, if the bid submitted is contingent upon award of both tenders, that must be noted on the bid submission. The Town will be faced with uncoupling of recycling and solid waste material in the near future, bidders have an opportunity to submit bids with coupling and without coupling, we encourage bidders to submit both if at all possible
7. Commercial contracts are available within the Town of Outlook, however the Town of Outlook does not facilitate commercial waste disposal contracts, this is a contract between businesses and their chosen waste disposal contractor.

Saskatchewan Workers Compensation clearance shall be included with the tender documents.
